Re: Regional Compliance Order

License Renewal: Bank of Canada and U.S. Federal Reserve Bank

September 31st, 2026

In compliance with BN/NA20072601 and RC-073126-001 of Free State, South Africa, all crown companies and private companies in Canada and the United States of America licensed to conduct financial trade with former British political territory, Orange River Sovereignty (1848 – 1854), its heirs, and successors at Free State, South Africa, (1854 – 2026) are subject to immediate license renewal.

A. For agencies acting on behalf of His Majesty, the King of Canada:

1. We remind that all licenses and authorisations previously granted to the crown company, Bank of Canada, in trade with the Republic of South Africa, its diplomatic and financial institutions, including the South African Reserve Bank, are retired.
 - a. The Bank of Canada may make a request for the renewal of its license in writing by contacting regional-integration@eco-6.org
 - b. Executive applications for renewal by the Bank of Canada must be re-submitted in accordance with upper-house regulations of Free State. Documents must be under coverletter of a signator at the executive rank of clan king in the peerage of Bakhelokoe Monarchy, or Duke at the peerage of Edinburgh, Scotland,
 - c. All Canadian applications must be approved at the Royal Canton of Little Africa.

B. For agencies acting on behalf of the Office of the President of the United States of America:

We remind that all licenses and authorisations previously granted to the Federal Reserve Bank to trade with U.S. Securites and Exchange Commission (SEC), Central Index Key (CIK) 0000932419, Republic of South Africa, its diplomatic and financial institutions, including the South African Reserve Bank, are retired.
 - a. The Federal Reserve Bank may apply for the renewal of its license in writing by contacting regional-integration@eco-6.org
 - b. Executive applications for renewal by the Federal Reserve Bank must be re-submitted in accordance with upper-house regulations of Free State. Documents must be under coverletter of a signator at the executive rank of President, or Duke at the peerage of Edinburgh, Scotland,
 - c. All U.S.A. applications must be approved at the Royal Canton of Little Africa.

C. Crown/Private companies of Canada and the United States of America previously engaged at Free State with U.S. Securites and Exchange Commission (SEC), Central Index Key (CIK) 0000932419, Republic of South Africa, must have a registered business name and number with the Private/Crown company of the Monarchy of Free State, South Africa, Enterprise Number: 2026/335702/07, Enterprise Name: K2026335702 (SOUTH AFRICA) (PTY) LTD.
