#### Ref.: No.14/15 2026 African Land Reform –Berlin Conference Foreign Border Status

The Reparations Treasurer of the Sixth Region presents to the ECO-6 Secretariat, Rex of the House of Kings, and also to the continental realms, municipalities, provinces, states, regional blocks, and all relevant institutions

#### At the request of the House of Kings

In the forensic accounting of continental lands and opening of borders for the free movement of people, goods, and services, and procurements in the continental sea, air, and land transportation (SALT) system, reports on the status of foreign borders in Africa:

1. CONFIRMS special report No. 14/2026 on the abatement of all signatories to the Berlin Conference on African lands and other creditor claims, per European Commission, Brussels, external reference devco.a.4(2021)191388.
2. CONFIRMS special report No. 15/2026 on Foreign Border Tax Revenue, with the placement of all foreign borders in Africa from the erection of Elmina Castle in 1482 until Return of 2019, under erasure per Section 7 (1, 2) of the Foreign Border Tax Act (2021).
3. CONFIRMS that the lands of the continent of Africa are recovered from the Berlin Conference signatories and registered by the kingdoms in *DOMINUS, Record I.I-A-001-2026* with noted "rights and privileges reserved over the recapitalisation and forfeiture of continental lands and/or tenants, including: governments, corporations, embassies, regional bodies, continental institutions, et al."

**Subject: Notice to African Creditors (Policy Code. ECO-6/AcFTA00246)**

Dear Mr Chairman,

I thank you for your letter sent to President Ursula Von Der Leyen.

I took note of your notice and would like to recall the European Commission's commitment to support African countries in their efforts of preserving debt sustainability and finance sustainable development.

Even though the European Commission is not a creditor, we work closely with European Union Member States, international organisations and our African partner countries to address the debt situation. The European Commission strongly supported the G20/Paris Club Debt Service Suspension Initiative, which provided immediate liquidity to many countries to respond to the health and economic consequences of the pandemic. We also welcome the G20 agreement on a "Common Framework for debt treatment beyond the Debt Service Suspension Initiative" that can bring effective debt reduction for countries that need it. We will continue to support the effective implementation of this framework.

Furthermore, the Commission recently approved a support of €183 million to the IMF Catastrophe Containment and Relief Trust (CCRT), which to free up fiscal space in 29 of the most vulnerable countries, most of them are in Africa.

We look forward to continue to engage with you on this important topic.

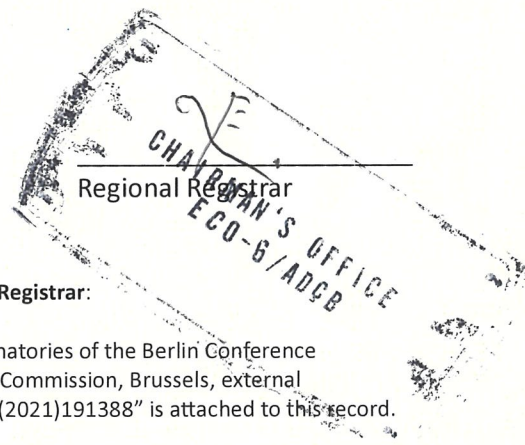
